Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract (see press release dated Mar. 1st, 2016), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 269.646 own shares during the period between 04 May 2020 and 08 May 2020 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 153.118 own shares and consequently this results in a net increase of 116.528 own shares.
