Repurchase of shares in the context of the liquidity contract

In the framework of the liquidity contract (see [press release dated Mar. 1st, 2016](#)), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 173,657 own shares during the period between 20 January 2025 and 24 January 2025 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 137,826 own shares and consequently this results in a net increase of 35,831 own shares.
