

Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract ([see press release dated Mar. 1st, 2016](#)), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 155,573 own shares during the period between 25 April 2022 and 29 April 2022 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 78,000 own shares and consequently this results in a net increase of 77,573 own shares.
