Repurchase of shares in the context of the liquidity contract

In the framework of the liquidity contract (see [press release dated Mar. 1st, 2016](#)), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 466,000 own shares during the period between 7 April 2025 and 11 April 2025 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 447,112 own shares and consequently this results in a net increase of 18,888 own shares.
